PRIVACY NOTICE

RESPONSIBLE IDENTITY AND ADDRESS

The responsible entity for the personal data that you provide is VAISHVIK RA Asistencia en Regulación Sanitaria S.A.S. de C.V. (hereinafter "VAISHVIK RA"), whose official address is Cuzco 909, Colonia Lindavista, Alcaldía Gustavo A. Madero C.P. 07300, Ciudad de México.

PERSONAL DATA AND SENSITIVE PERSONAL DATA PROCESSED BY VAISHVIK RA

VAISHVIK RA, as part of its service provision, will treat the following categories of personal data:

- Identification
- Contact
- Employment

VAISHVIK RA informs you that it will not process sensitive data for its service provision and that in case of collecting these data, the necessary modification will be made to this instrument.

PRIMARY PURPOSES

VAISHVIK RA will process your personal data to comply with the following primary and necessary purposes:

- 1. To attend, register and follow up on requests for services that are made.
- 2. To validate the information veracity and quality provided by its OWNER.
- 3. To comply with and follow up on the actions derived from hiring VAISHVIK RA service.
- 4. To manage access to confidential information by the OWNERS.
- 5. To comply with the representation made by VAISHVIK RA to third parties or authorities.

We inform you that you cannot oppose VAISHVIK RA to cease the processing of your data for these purposes, since this treatment is necessary to provide the requested services.

SECONDARY PURPOSES

VAISHVIK RA will keep your personal information, necessary for the following purposes, although these are not necessary for the service you request, since it allows and facilitates us to provide you with better care:

- 1. For possible future contacts
- 2. Advertising and informative communications sending related to health issues, marketing or campaigns
- 3. Informative, administrative and/or commercial purposes related to VAISHVIK RA Asistencia en Regulación Sanitaria
- 4. To carry out statistical reports, after applying a mechanism for personal data dissociation.

In case you do not want your personal data to be processed for any or all additional purposes, within 5 (five) business days from the date you provided the information, you must communicate your refusal to the email contacto@vaishvikra.com.mx with the following information:

- 1. Full name and provided email
- 2. Copy of valid official identification
- 3. The date you provided us with your personal data.
- 4. The secondary purpose(s) for which you do not want your personal data to be used.

The refusal to use your personal data for additional purposes may not be a reason to deny the requested services or to terminate the relationship established with us.

TRANSFERS

VAISHVIK RA, to comply with the necessary purposes previously described or other required by law or by the competent authorities, will transfer the necessary personal data, provided that the recipient of the data assumes the same obligations that VAISHVIK RA has assumed.

VAISHVIK RA, para cumplir las finalidades necesarias anteriormente descritas u otras aquellas exigidas legalmente o por las autoridades competentes, transferirá los datos personales necesarios, siempre que el receptor de los datos asuma las mismas obligaciones asumidas por VAISHVIK RA. Likewise, VAISHVIK RA undertakes to transfer only the information that is necessary for the same purpose for which this notice is issued.

We can also share your information in these cases:

- I. When any governmental authority or official responsible for enforcing the law reasonably requests or requires such information;
- II. When it is required by law or in response to any legal process;
- III. When it is reasonably necessary to carry out a legal investigation.

ARCO RIGHTS AND/OR REVOCATION OF CONSENT

You or your legal representative may exercise any of the rights of access, rectification, cancellation or opposition (hereinafter "ARCO rights"), as well as revoke your consent for the processing of your personal data by sending an email to contact@vaishvikra.com.mx, who may request for your protection and benefit, documentation that proves corrections to the data in case you request their rectification. You can request that the personal data that VAISHVIK RA keeps be deleted. Likewise, you can limit the use and distribution of your personal data through a written request to the company. However, the company may be obliged under applicable law to keep some or all of your personal data. It is important that the changes you intend to make to your personal data are correct; in addition, data that the company must keep by obligation or legal provision will not be eliminated.

The request must be submitted by the OWNER or its legal representative to the email address previously mentioned, such request must contain:

- I. The full name of the OWNER and address or other means to communicate the response, including email address.
- II. The documents that prove its identity or the legal representative's.
- III. The clear and precise description of the personal data regarding the person seeking to exercise its rights.
- IV. Any other element that facilitates the location of the OWNER's personal data.

VAISHVIK RA will notify the OWNER within a maximum of 20 (twenty) calendar days, counted from having received the request for access, rectification, cancellation or opposition, the decision adopted, in order to make it effective within the following 15 calendar days. These terms may be extended for an equal period when, at the discretion of VAISHVIK RA, the circumstances of the case justify it.

The right of access proceeds when the OWNER wishes to know which of its personal data is held by VAISHVIK RA and the privacy notice that is applicable to it.
